SCHEDULE OF FEES AND COSTS 2017 IGCSE1 & IGCSE2, AS LEVEL 1 & AS LEVEL 2

Entrance Assessment:	R500.00 non-refundable
Registration Fee:	A once-off, non-refundable registration fee of R1000 is payable on application for enrolment of each new student.
Deposit Requirement:	One term's tuition fees are required as a security deposit per student. This is <u>fully</u> refundable when the student leaves Summerhill College provided a full term's notice is given. If correct notice is not given, the deposit is forfeited regardless of the reason for the late notice. The deposit is payable BEFORE the student is allowed to start.
Sibling Discount:	2 nd and Subsequent Siblings receive a discount. Please contact Accounts department 011 468 2772.
Annual Fee Discount:	A 5% discount of R3840 is given if the annual fee is received on or before 31st December 2015. The security deposit amount remains at R25 600. (There is no discount for paying termly.)
TUITION FEES:	R76 800 per annum
SECURITY DEPOSIT:	R25 600 (equal to one term's fees) * Please note that once the deposit has been paid, it cannot be refunded under any circumstances should your child not take up the place offered. Deposits are only refunded provided a full term's notice is given and the student must be enrolled and attending Summerhill College.
EXAM FEES:	Applicable to IGCSE2 and AS2 only. Fees are charged per subject by Cambridge and will be invoiced separately. Fees will be advised.
CAMP FEE:	Leadership Camp for IGCSE2 only (prices to be confirmed)
TEXT BOOKS:	See separate price list.
TRANSPORT: (optional)	Payable monthly in advance. Prices only available in January 2017.
UNIFORM:	See separate price list

- * The deposit must be equal to one term's fees at all times and thus will be topped up periodically. It is fully refundable provided Summerhill College notice requirements are fulfilled and school fees are up to date.

Basic Fee Structure:

Tuition fees are calculated annually and divided by twelve to achieve a monthly instalment which must be paid over 12 months on the first day of each month commencing 1st January 2017 for the month period to 1st December 2017.

All tuition fee payments (unless paid in advance) must be made by debit order.
